Prohibited items

1. Luxury goods: clothes, shoes, bags, perfume if the unit value is more than 300 EURO*;
2. Electronics (phones, headphones, computers, etc.) if the unit value is more than 750 EURO**;
3. Lasers, sensors, radar systems, optical materials, etc.;
4. Microscopes, detectors, x-ray installations;
5. Precious metals, stones and all ivory products;
6. Perfumes, nail polishes, etc. flammable cosmetics;
7. Batteries, accumulators;
8. Watches exceeding the value of 500 EURO;
9. Weapons of all types (cold steel and firearms), explosives, including imitation, main parts and components. Firearms-type items (presented as pistols, bullets, grenades, toy guns, weapon-type keychains, etc.;
10. Ammunition - bullets, bombs, grenades, rockets, flares, incendiary bombs, smoke bombs, air bombs, flares, tear gas bombs, gas bombs, ground bombs, grenade, cannonball, gunpowder etc. Various grenade-shaped products, including toys;
11. Spy equipment - covert listening devices, photographic devices, burst transceivers, one-time code books, secret writing instruments, electronic listening and secondary code books, cryptographic tools, electronic listening devices and interception devices, etc.;
12. Toxic and radioactive substances;
13. Biologically infectious substances;
14. Perishable foods (for example, foods that can spoil quickly);
15. Live animals, birds, fish, living creatures, except silkworms, bees and leeches;
16. Live plants and seeds;
17. Radio-electronic communications (except for children's toys, baby monitors, alarms, gadgets, routers, non-professional walkie-talkies);
18. Narcotic drugs, precursors and medicines containing them;
19. Alcohol products;
20. Cash and cash equivalents;
21. Plant protection products (pesticides, herbicides);
22. Fishing nets;
23. Industrial machines and equipment and their parts;
24. Internal combustion engines (except boat engines);
25. Multimeters, oscilloscopes, instruments for measuring electrical quantities;
26. Medical devices (except for thermometers and blood pressure measuring devices);
27. Central heating boilers;
28. Printed circuit boards (circuits) without electronic components;
29. Layouts and mannequins;
30. Graphite brushes and electrodes;
31. Ashes, human remains, human organs and (or) human tissues, blood and its components;
32. Pornographic materials, religious materials calling for extremism or terrorist activities, materials aimed at promoting Nazi paraphernalia or symbols or paraphernalia or symbols confusingly similar to Nazi paraphernalia or symbols, materials containing information that

- may harm political or the economic interests of the EAEU member states, their state security, health and morality of citizens; materials containing state and commercial secrets;
33. Items of exceptional and cultural value manufactured more than 50 years ago;
 34. Aircraft such as drones;
 35. Tobacco products;
 36. Numbered units and parts of cars and motorcycles;
 37. Goods under embargo;
 38. High frequency echo sounders;
 39. Food of animal origin;
 40. Food products of plant origin;
 41. Goods exported from the customs territory of the Eurasian Economic Union (hereinafter referred to as the Union) in respect of which export customs duties are established by the legislation of a member state of the Union (except for fuel located in ordinary tanks of a vehicle for personal use, and in quantities not exceeding 10 liters in a separate container);
 42. Natural diamonds (with the exception of diamonds worth no more than 75 thousand US dollars exported from the customs territory of the Union);
 43. Vehicles not included in the list of certain types of motor vehicles and trailers for motor vehicles and motor vehicles, which are vehicles for personal use, approved by the Decision of the Board of the Eurasian Economic Commission dated June 30, 2017 No. 74;
 44. Internal combustion engines (except for outboard boat engines);
 45. Central heating boilers classified in subposition 8403 10 of the EAEU HS;
 46. Machines, mechanisms, equipment classified in positions 8426 - 8430, 8433 - 8442, 8444 00 - 8449 00 000 0, 8453 - 8464, from 8465, 8466, 8468, 8474 - 8480, 8486, 8514, 8530, 8534 00 , 8535, 8545, 8548, 9024, 9027, 9030 and 9031 CN VED of the EAEU (except for mowers for lawns, parks or sports grounds, household circular saws);
 47. Tanning beds;
 48. Medical technology and equipment (except for syringes, needles, catheters, cannulas, similar instruments, equipment for measuring blood pressure, temperature, as well as equipment necessary for medical use);
 49. Medical, surgical, dental or veterinary furniture (except for medically necessary hospital beds with mechanical attachments);
 50. Hairdressing chairs and similar chairs, parts thereof;
 51. Equipment and equipment for photographic laboratories classified in heading 9010 of the EAEU CN FEA;
 52. Devices, equipment and models intended for demonstration purposes, classified in heading 9023 00 of the EAEU CN FEA;
 53. Games operated by coins, banknotes, bank cards, tokens or similar means of payment;
 54. Goods in respect of which export control measures are applied, in cases and in the manner established in accordance with the legislation of a member state of the Union.

*** Luxury goods (below 300 EUR):**

- Perfume and eau de toilette
- Skin care or decorative cosmetics (except medications), including sunscreens; Cosmetics for manicure or pedicure
- Hair products
- Shaving products, including gels and creams before and after shaving
- Deodorant, bubble bath, depilatory products, antiseptics
- Wigs, fake beards, eyebrows and eyelashes
- Bags, suitcases, briefcases, school backpacks, cases for glasses, bags for video equipment, bags for musical instruments, cases for weapons. Purses, wallets, sports bags, jewelry boxes, cutlery containers.
- Travel kit (personal hygiene products, sewing kits, shoe or clothing cleaning kits)
- Clothing and accessories made of genuine leather or artificial leather
- Coats, capes, raincoats, anoraks, jackets, jackets, trousers, shorts (except swimwear), breeches, dresses, skirts, overalls, shirts, blouses, T-shirts, underwear, pajamas and other clothing made of cotton, synthetics, other textiles materials
- Ski suits

- Tights, stockings, socks and other hosiery, including compression hosiery (for example, stockings for varicose veins)
- Shoes
- Gloves, mittens, mittens
- Shawls, scarves, veils, etc.
- Ties, bow ties
- Hats, caps and other head wears
- Carpets and other textile floor coverings
- Diamonds, pearls, precious stones and semi-precious stones, precious metals
- Dishes, kitchen utensils, other kitchen utensils and toiletries made of porcelain, clay, ceramics
- Bottles, flasks, jars, pans, vials, ampoules and other containers, glass used for transporting or packaging goods;
- Wristwatches, pocket watches and other timepieces, including stopwatches, including those using precious metal
- Instrument panels and clocks of similar type for vehicles, aircraft, spacecraft or ships

**** Luxury goods (below 750 EUR):**

- Tables, floors, walls, windows, ceilings or roof fans, including those with an independent electric motor output not exceeding 125 W.
- Refrigerators, freezers
- Equipment for preparing hot drinks or for cooking or heating food
- Scales, including children's scales
- Printers, scanners, copying machines
- Washing machines, dryers
- Sewing machines
- Electronic calculator
- Vacuum cleaner
- Hairdryer
- Microwave ovens, stoves, toasters, coffee makers
- Mobile and landlines phones
- Machines for receiving, converting, transmitting or regenerating voice, images or other data, including switching and routing apparatus
- Radio navigation technology
- Fire alarm, burglar alarm
