Prohibited items

- 1. Separate batteries outside of devices;
- 2. Liquids containing alcohol;
- Weapons of all types (cold steel and firearms), explosives, including imitation, main parts and components. Firearms-type items (presented as pistols, bullets, grenades, toy guns, weapontype keychains, etc.;
- 4. Ammunition bullets, bombs, grenades, rockets, flares, incendiary bombs, smoke bombs, air bombs, flares, tear gas bombs, gas bombs, ground bombs, grenade, cannonball, gunpowder etc. Various grenade-shaped products, including toys;
- 5. Spy equipment covert listening devices, photographic devices, burst transceivers, one-time code books, secret writing instruments, electronic listening and secondary code books, cryptographic tools, electronic listening devices and interception devices, etc.;
