- 2. Ammunition bullets, bombs, grenades, rockets, flares, incendiary bombs, smoke bombs, air bombs, flares, tear gas bombs, gas bombs, ground bombs, grenade, cannonball, gunpowder etc. Various grenade-shaped products, including toys;
- 3. Spy equipment covert listening devices, photographic devices, burst transceivers, one-time code books, secret writing instruments, electronic listening and secondary code books, cryptographic tools, electronic listening devices and interception devices, etc.;
- 4. Toxic and radioactive substances;
- 5. Biologically infectious substances;
- 6. Perishable foods (for example, foods that can spoil quickly);
- 7. Live animals, birds, fish, living creatures, except silkworms, bees and leeches;
- 8. Live plants and seeds;
- 9. Radio-electronic communications (except for children's toys, baby monitors, alarms, gadgets, routers, non-professional walkie-talkies);
- 10. Narcotic drugs, precursors and medicines containing them;
- 11. Alcohol products;
- 12. Cash and cash equivalents;
- 13. Plant protection products (pesticides, herbicides);
- 14. Fishing nets;
- 15. Industrial machines and equipment and their parts;
- 16. Internal combustion engines (except boat engines);
- 17. Multimeters, oscilloscopes, instruments for measuring electrical quantities;
- 18. Medical devices (except for thermometers and blood pressure measuring devices);
- 19. Central heating boilers;
- 20. Printed circuit boards (circuits) without electronic components;
- 21. Layouts and mannequins;
- 22. Graphite brushes and electrodes;
- 23. Ashes, human remains, human organs and (or) human tissues, blood and its components;
- 24. Pornographic materials, religious materials calling for extremism or terrorist activities, materials aimed at promoting Nazi paraphernalia or symbols or paraphernalia or symbols confusingly similar to Nazi paraphernalia or symbols, materials containing information that may harm political or the economic interests of the EAEU member states, their state security, health and morality of citizens; materials containing state and commercial secrets;
- 25. Items of exceptional and cultural value manufactured more than 50 years ago;
- 26. Aircraft such as drones;
- 27. Tobacco products;
- 28. Numbered units and parts of cars and motorcycles;
- 29. Goods under embargo;
- 30. High frequency echo sounders;

- 31. Food of animal origin;
- 32. Food products of plant origin;
- 33. Goods exported from the customs territory of the Eurasian Economic Union (hereinafter referred to as the Union) in respect of which export customs duties are established by the legislation of a member state of the Union (except for fuel located in ordinary tanks of a vehicle for personal use, and in quantities not exceeding 10 liters in a separate container);
- 34. Natural diamonds (with the exception of diamonds worth no more than 75 thousand US dollars exported from the customs territory of the Union);
- 35. Vehicles not included in the list of certain types of motor vehicles and trailers for motor vehicles and motor vehicles, which are vehicles for personal use, approved by the Decision of the Board of the Eurasian Economic Commission dated June 30, 2017 No. 74;
- 36. Internal combustion engines (except for outboard boat engines);
- 37. Central heating boilers classified in subposition 8403 10 of the EAEU HS;

- 40. Medical technology and equipment (except for syringes, needles, catheters, cannulas, similar instruments, equipment for measuring blood pressure, temperature, as well as equipment necessary for medical use);
- 41. Medical, surgical, dental or veterinary furniture (except for medically necessary hospital beds with mechanical attachments);
- 42. Hairdressing chairs and similar chairs, parts thereof;
- 43. Equipment and equipment for photographic laboratories classified in heading 9010 of the EAEU CN FEA;
- 44. Devices, equipment and models intended for demonstration purposes, classified in heading 9023 00 of the EAEU CN FEA;
- 45. Games operated by coins, banknotes, bank cards, tokens or similar means of payment;
- 46. Goods in respect of which export control measures are applied, in cases and in the manner established in accordance with the legislation of a member state of the Union.
